ICADE is proud of its strong tradition of educating young lawyers with the practical skills necessary to excel in their professions. With the ever-increasing globalization of the legal field, we believe it is essential for international lawyers to have a strong understanding of another jurisdiction, be able to operate in a multi-cultural environment and develop a global network of professional contacts. As a result, we offer students in the E-1 Joint Global Program the opportunity during their fourth year of law school to study for an LL.M. in the People's Republic of China, the United States or France.

As part of this program, we are pleased to offer students the rare opportunity to study for an LL.M in Chinese law (in English) in either Beijing or Shanghai, at two of the country's best universities. Apart from learning about one of the world's most important legal systems, students also have the chance to take language courses and live in a country that has become the center of global business.

We have also expanded the E-1 Joint Global Program to a number of top U.S. universities, including LL.M. degrees in subjects such as U.S. Law, Business, Banking, and Intellectual Property. Most LL.M. degrees give access to the New York Bar examination. In addition, the E-1 Joint Global Program also offers the opportunity for students to study for an LL.M. at Université de Strasbourg in France, which gives entry to the Masters' program required to sit for the lawyer licensing examination (*examen du barreau*).

This unique international program, which offers students a diverse choice of LL.M. programs in different countries, reaffirms our strong commitment to helping our students gain the knowledge and ability to work as international lawyers.

I hope you will attend the information sessions to learn more about this program and hear from former students about their positive experiences. I have no doubt that this program will serve as a source intellectual and personal richness as your begin your careers as successful lawyers.
