As an exchange student you will be allowed to take courses from different **bachelor's degrees within the Faculty of Law and from different years (only 4th and 5th year are available)** in English or Spanish.

Please bear in mind that some syllabi may not be available yet.

Number of credits (ECTS) allowed per semester:

- Minimum: 1 course per semester (3 or 6 ECTS).
- Maximum: 36 ECTS per semester.

On average 1 ECTS credit point is equivalent to 25 working hours, including lectures, seminars, homework and exercises.

Keynotes:

SEM 1 = September to January ; **SEM 2** = January to May.

SEM 1 or SEM 2 = a semester-only course that can be taken either in the autumn OR in the spring semester. The content is exactly the same in both semesters.
