# Diploma in Legal Studies in Spain (DLS).

## Description and objectives

It is an optional non-degree programme designed for exchange students nominated to study at the Comillas Faculty of Law either for one semester or the full academic year. It covers different courses within the field of International Legal Studies as well as a course about cultural aspects of Spain and a Spanish language course.

Exchange students can apply for the Diploma alongside their Comillas courses during their exchange period at the Faculty of Law.

In addition to receiving the transcript of records a certificate will be awarded as long as the student successfully completes at least 20 ECTS credits from the programme.

## Requirements

In order to be eligible for this Diploma exchange students must choose at least 20 ECTS from the list and pass those 20 credits at the end of the semester.

Students may put some of the courses that they may have selected for the normal enrolment for exchange or add additional courses from the list below.

## Language of tuition

Classes are taught in English (except the Spanish language course).

## Duration

One semester, either in the fall or the spring semester.

## Price

40€ + shipping fees depending on the home country (EU countries: 40€. Non-EU countries within Europe: 50€. Rest of the world: 55€).





















## Application Procedure

1. Upon arrival exchange students must select the option "register of the Diploma in Legal Studies in Spain" / Solicito la inscripción en Diploma Legal Studies in Spain" when completing the phase II of their online application (Courses selection) within the official enrolment dates for each semester.
2. At the end of their exchange and provided that they have passed at least 20 ECTS credits they can apply for the diploma certificate through Registry. They must pay the fee and the shipping fees by card + send their [Diploma certificate request form](#) + a copy of their passport/ID to [solicitud.titulos@comillas.edu](mailto:solicitud.titulos@comillas.edu) . The Diploma will be sent by post to their home address.
