Face-to-face activities

Students will work in teams to prepare the oral presentation of the topic assigned by the teacher.

Grading

Ordinary exam call:

The mark for the written exam represents 60% of the course's global grade.

The continuous assessment activities account for 40% of the final mark, and the written analysis or commentary (short essay) accounts for 20%.

Extraordinary examination / Third and subsequent exam calls:

The exam will be worth 100% for those students who have not passed the continuous assessment tests. For those students who have passed the continuous assessment tests, the teacher will apply the most favourable from the following two options:

a) to award the exam 100% of the final grade;

b) to award the exam 60% of the final grade, considering the continuous assessment grades obtained during the course.
